What data do we collect?

Skapjana Translate & Create collects the following data:

- Personal identification information (name, email address, phone number, etc.)
- Company information of corporate customers and suppliers (company name, corporate identity number)
- Payment details of suppliers (payment history and payment information)

How do we collect your data?

You directly provide Skapjana Translate & Create with most of the data we collect. We collect data and process data when you:

- Use or view our website via your browser's cookies.
- Contact us via email.
- Place an order for any of our products or services.

In addition to the data you provide to us, we may also collect personal data from someone else (known as a third party). The data we collect from third parties are as follows:

- Address details from public records to make sure we have the correct details for you.
- Credit rating information from credit rating agencies, banks or information companies.

How will we use your data?

Skapjana Translate & Create collects your data so that we can:

- Process your request for a quote or order and manage your account and payment (customers)
- Contact you and collaborate as agreed and manage payment (suppliers).

How do we store your data?

Skapjana Translate & Create securely stores your data as follows:

- Microsoft 365/OneDrive (see www.microsoft.com/en-us/trust-center/privacy/gdproverview for details of where and how your data is stored)
- wix.com (see www.wix.com/about/privacy for details of where and how your data is stored)

Skapjana Translate & Create will keep your data for a maximum of seven (7) years if required under Swedish law. Once this period has expired, we will delete your data. Other

data stored in Microsoft 365/OneDrive will be deleted as soon it is no longer required to fulfil a stated purpose as described above under *How will we use your data*. Sensitive personal data is deleted by using Bitdefender File Shredder (for files). You can also request for your data to be removed from our website (hosted by Wix).

You have the right at any time to stop Skapjana Translate & Create from contacting you for marketing purposes.

What are your data protection rights?

The right to rectification – You have the right to request that Skapjana Translate & Create correct any information you believe is inaccurate. You also have the right to request that Skapjana Translate & Create complete the information you believe is incomplete.

The right to erasure – You have the right to request that Skapjana Translate & Create erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Skapjana Translate & Create restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Skapjana Translate & Create's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Skapjana Translate & Create transfer the data that we have collected to another organization, or directly to you, under certain conditions.
